Rental Terms

1. No driver's license required to rent a boat under 30 horsepower.
2. The minimum age of the renter is 18 years old.
3. The boat is inspected by the tenant and receives it, if it satisfies him and if there are any damages reported to the owner
4. The boat is delivered full fuel and on delivery the consumption burdens the customer after on-site payment to the company.
5. The boat is insured for bodily injuries and property damage resulting from collision at sea to other persons.
6. The company does not bring responsibility for the loss or damage of the fortune of the customer during the rental period.
7. The customer agrees and accepts:
 - I. To deliver the boat in the condition that it was received and any damage that will be caused to the vessel or the machine from bad handling or negligence burdens in full the customer.
 - II. To deliver the boat before sunset, early return does not entitle him to claim a refund of money.
 - III. Do not allow any of the persons that travelling during the rental to operate the boat.
 - IV. The maximum removal of the boat from the coast shall not exceed 2 N.M.

The legislation commands that:

In accordance with the General Port Regulation (Γ.Κ.Λ.) No 38 regulating the leasing of motor boats and speed of small vessels:

- Any boat that is rented must have the operating license (color blue and not green which marks a boat as amateur) and state that it is professional.
- The licence of the rental boat must be marked with a special indication of its destination by the entry in red ink of the phrase «ΕΚΜΙΣΘΟΥΜΕΝΟ ΣΥΜΦΩΝΑ ΜΕ ΤΙΣ ΔΙΑΤΑΞΕΙΣ ΤΟΥ Αρ. 38 ΓΕΝΙΚΟΥ ΚΑΝΟΝΙΣΜΟΥ ΛΙΜΕΝΑ» (rented in accordance with the provisions of No. 38 general Regulation Port).
- Violators are fined. The amount can reach 40,000.00 €

The landlord must deliver with the leasing to each tenant:

- (a) The original license of the rental boat and the permission to sail.
- (b) A copy of the insurance contract.
- (c) A certified copy of the leasing license
- (d) Copies of the general Port Regulations (G.K.L.) 20, 23 regulating the movement and circulation of motor boats and high-speed craft and G.K.L. No. 38.

Warranty:

As a charterer you are required to advance for any damages the amount of €300 (in cash or credit card) which will returned at the end of the lease and the final inspection on the return of the boat.

Weather conditions:

The lease and the boat deposition are normally carried out when at the pickup point the winds do not exceed 4 Beaufort and it is allowed by the Port Authorities. In the event of adverse weather conditions, which prohibit departure on the day of commencement of your lease, the amount of the guarantee is refunded and you postpone the rental for another day if you wish and there is availability.
